
4,000m RC Drilling Program Commences at Sorpresa Project - Regional Prospect Intersects 2m @ 9.11g/t Gold

Rimfire Pacific Mining NL (ASX:RIM) ("Rimfire" or "The Company") is pleased to report that a 19 hole, 4,000m Reverse Circulation (and Diamond core tail) drilling campaign has commenced at multiple priority targets across the Sorpresa Gold and Silver Project, Fifield NSW. Structural, magnetic, gravity and induced polarization (IP) targets are being tested down dip of near surface, often high grade oxide gold and silver mineralization, searching for primary depth extensions (Figures $1\sim4$).

A concurrent regionally focused RC drill program to the west of Sorpresa is performing target definition work at three prospects. Results from the first hole, at Golden Green South, have returned a very promising **2m @ 9.11g/t Au** from 42m (Fi 401). Further results are awaited and drilling continues at Rabbit Hill and Twin Shafts (Figure 1).

Highlights




Figure 2: Sorpresa Implicit Model Long Section looking west illustrating higher grade (a) Gold and (b) Silver mineralisation and new down dip and down plunge extensional targets ready for RC and Diamond tail drilling. (Implicit Model is an interpretive exploration model imaging (a) Gold: yellow >0.2g/t Au, red >0.5g/t Au, purple >2g/t Au), (b) Silver: Light Grey > 31g/t Au, Dark grey > 62g/t Ag).

- ☐ The Sorpresa Drilling program will test a range of gold/silver extensions and plunge targets (Figure 2). Drilling commenced at Roadside North with aggressive down dip & plunge step-out holes (Figures 2~4). Roadside, Original Sorpresa, Join-up and Boundary Gate East (BGE) are each targeted for gold, including extensions of the high grade gold results at BGE 1.
 - RC Drilling at Twin Shafts and Rabbit Hill is nearing completion, results are awaited.



Additional auger drill lines were completed at Yoe's Lookout, aiming to extend the strike of the gold geochemical anomaly from 1km to approx. 1.5km. Auger drilling is now underway at Eclipse North.

Executive Chairman, John Kaminsky stated:

"The commencement of a second RC rig at Fifield represents an exciting next stage of exploration for the Company as we eagerly implement further Discovery Growth drilling at Sorpresa.

Significant effort has been directed to careful planning of deeper holes into the Sorpresa gold and silver mineralized system, aiming to test multiple targets and concepts for high grade shoots. We remain confident in the robustness of the Sorpresa system to generate extensions and intersections. There are some potentially significant outcomes from the next phase of work at each area within Sorpresa, as we strive to:

- Understand and extend the down dip and down plunge position at Roadside North
- Resolve the high grade gold plunge position at Join-up and its relevance to BGE
- Re-engage with the high grade plunging gold shoot at Roadside South
- Expand the high grade gold position at BGE

This next phase of work at Sorpresa is very timely on the back of successful regional work in the last quarter. The intersection at Golden Green South was a pleasant surprise, **2m @ 9.11g/t Au** in a single drill hole.

Similarly, the growth in the bedrock gold anomaly at Yoe's Lookout is certainly raising interest within the Company. Two discrete mineralization target types are emerging at Yoe's, and we will be tracking this closely.

The ongoing regional work within a 6km radius of Sorpresa has made important progress and is very complimentary to the efforts being applied at Sorpresa.

We look forward to reporting further updates in the current period."

Regional RC Drilling - Rabbit Hill, Golden Green South, Twin Shafts.

Reverse Circulation (RC) drilling targeted shallow oxide mineralisation near historic workings and remains ongoing. In the case of Golden Green South, drilling was following up an historical intersection of 10m @ 0.43 g/t Au from 6m which included 1m @ 2.8 g/t Au in Fi 55. Given the recent success at Golden Green South, further drilling is planned.

Two holes were completed at Rabbit Hill (results awaited), and a three hole program at the 40m deep Twin Shafts workings is in progress (Figure 1). Drilling is also being planned for the Golden Green historical workings and the associated basement auger gold anomaly located there, which is currently 500m long @>20ppb Au, and remains open.

ABOUT RIMFIRE PACIFIC MINING

Rimfire Pacific Mining is an ASX listed (code: RIM) resources exploration company that has its major emphasis focused at Fifield in central NSW, located within the Lachlan Transverse Zone.

In 2010 the Company delivered a greenfields gold and silver discovery, named "Sorpresa", in the Fifield district. Subsequent exploration has provided evidence that the 8km² wider Sorpresa area is now considered a significant gold mineralized system of some promise. The gold is predominantly native gold.

The current main Sorpresa Strike line containing gold and silver mineralization is approximately 1.7km in length and is at various stages of further discovery extension drilling.

The Company has now established multiple project areas of importance involving hard rock Gold (Au), Silver (Ag), Platinum (Pt) and Base Metal within an extensive prospective 20km^2 area at Fifield, which is part of the contiguous 313km^2 tenement position held.

Figure 1: Fifield Prospect and Concept Map with Current and Recent RC Drilling Activities





Figure 3: Roadside Area - Sorpresa Implicit Model illustrating higher grade Silver mineralisation and new down dip and down plunge extensional targets ready for RC and Diamond tail drilling. (Implicit Model is an interpretive exploration model imaging Silver: Light Grey > 31g/t Au, Dark grey > 62g/t Ag). Gold is not shown in this model.

(b) Long Section Looking West




Figure 4: RC Drilling will occur at Roadside, Original Sorpresa, Join-Up and BGE and are shown in plan view.


