REQUEST FOR TRADING HALT

Rimfire Pacific Mining NL (ASX: **RIM**) (the **Company**) requests an immediate halt to the trading of the Company's ordinary shares and listed options (RIM and RIMOB) quoted on the Australian Securities Exchange (**ASX**) in accordance with ASX Listing Rule 17.1.

The trading halt is requested pending an announcement by the Company to the market regarding a capital raising.

In accordance with ASX Listing Rule 17.1, the Company provides the following information in relation to the request:

- 4. The Company is not aware of any reason why the trading halt should not be granted or of any further information necessary to inform the market about the trading halt.
