

Phase 2 Drilling to Commence at Fifield

Highlights

- ✓ Phase 2 Drilling program will consist of an aircore drilling program focussing on the Southern Area with objective of obtaining;
 - a. rock samples from below transported soil cover to test for anomalous geochemistry on a range of magnetic geophysical targets where there has been no prior drilling of the bedrock, and
 - b. fresh magmatic and intrusive bedrock samples for whole rock geochemical analysis to make a robust assessment on characterisation of magma and similarity to Macquarie Arc volcanism.
- ✓ All landowner access agreements and NSW Government Environmental Resources Regulatory approvals are complete, so McLeod Drilling are expected to mobilise to site and commence drilling by end of November.




Figure 1: Locality Plan of Southern Area




Figure 1: Location Plan Rimfire Exploration Licences and Project Areas

Rimfire Pacific Mining NL ("Rimfire", "Company"; ASX Code "RIM") advises that the next phase of discovery activity for Southern Area will start imminently. The Phase 2 drilling program in the Southern Area will focus on obtaining rock samples from below transported soil cover to test for anomalous geochemistry on a range of magnetic geophysical targets where there has been no prior drilling of the bedrock. The program will also obtain magmatic and intrusive bedrock samples for whole rock geochemical analysis to make a robust assessment on characterisation of magma and similarity to Ordovician Macquarie Arc volcanism which hosts significant local deposits such as Cowal and Northparkes. These samples will preferably have minimal overprinting from weathering events as these events cause changes to the rock chemistry which can have the potential to affect quality of results (Figure 1).

Rimfire Managing Director, Craig Riley commented:

"Rimfire is excited to commence the next phase of its discovery program with the Phase 2 Drilling Program building on the insights gained from the Phase 1 Drilling. The results of the Phase 2 Drilling Program are expected to be released after assaying and QAQC checks are complete towards the end of 2019 and in combination with Phase 1 results will support the planning of the Phase 3 Drilling Program in Q1 2020."

Rimfire is exploring for a major copper / gold or gold mineralised system such as at Northparkes (Cu/Au) or Cowal (Au) on 915km² of Exploration Licences 100km west of Parkes in central NSW. Multiple prospects with potential for further gold discoveries exist in the area around Sorpresa which are part of Rimfire's 681km² contiguous tenements. Rimfire also holds two exploration licences covering 234km²; located 40 to 60kms south of the Fifield Project, in a prospective area now part of a moratorium associated with the MinEx Cooperative Research Centre program (minexcrc.com.au)
