#### SECTION 708A CLEANSING NOTICE

This notice is given by Rimfire Pacific Mining NL (**Company**) under Section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

The Company hereby confirms that:
